Background Questions for Dalton High School Band Chaperones 2018-2019

DO NOT continue with your application and screening if any of the circumstances listed below apply to you.

The following will automatically disqualify you from becoming a Dalton Band Camp Chaperone:

- Any felony offense, regardless of type
- Currently arrested or warrant outstanding
- Misdemeanor crime against a child or dependent adult
- Misdemeanor crime involving use of weapons
- Misdemeanor crime involving violence
- Misdemeanor crime involving theft, robbery, fraud or forgery
- Misdemeanor crime involving arson
- Misdemeanor crime involving public indecency
- Misdemeanor crime involving DUI, DWI, possession of controlled substances or drug paraphernalia

Disclosure: Volunteers and applicants are required to disclose any pending criminal charges. If charges are pending related to any criminal offense other than minor traffic violations and known to the Band Board, involvement with the Band as a volunteer will be temporarily suspended pending disposition of the case, service (or continued service) with the Band shall be within the absolute and exclusive discretion of the Band Board President or his/her designee.
